





This line represents last year's credit for completing an annual exam. It was called by a different name than this year's because of line four.

This line represents the old \$50 plan year deductible credit for completing an annual exam. Since we now have a monthly differential for this, there is no longer a deductible credit; so the annual physical completion now refers to the wellness premium.
