Subject: Adoption of a Resolution Honoring the Men's Track and Field Team

I respectfully request the Board of Regents approval of the following resolution honoring the Texas A&M University Men's Track and Field Team.

"WHEREAS, the Texas A&M University Men's Track and Field Team distinguished themselves by winning the 2017 NCAA Indoor Championships by half a point in winning the final event of the meet; and

WHEREAS, the title for the Aggie men served as the first indoor national team title for Texas A&M University and the fifth national team title overall for the men in the past eight years; and

WHEREAS, the Texas A&M University Men's Track and Field Team had an individual NCAA Indoor national champion with Fred Kerley in the 400 meters as he established a school record with a victory in 44.85 seconds; and

WHEREAS, the Texas A&M University men's 4-by-400 Relay Team established an NCAA Indoor meet record of 3 minutes, 2.80 seconds in winning a fourth NCAA Indoor relay title over the past eight years, and produced the top performance of the season with a collegiate record time of 3 minutes, 2.52 seconds; and

WHEREAS, The Texas A&M University Men's Track and Field Team had two NCAA Indoor silver medalists in an individual event with Will Williams (long jump) and Audie Wyatt (pole vault), and an NCAA Indoor bronze medalist with Mylik Kerley (400 meters); and

WHEREAS, Head Coach Pat Henry was named the Men's NCAA Coach of the Year by his peers and is to be highly commended for providing outstanding leadership in guiding the teams to championships and national recognition, and he collected his fifth men's title and ninth overall while in his 13<sup>th</sup> season at Texas A&M University, and now has 36 NCAA championships in his career; and

WHEREAS, seven Texas A&M University athletes were honored with nine All-America first-team honors from NCAA Indoor Championship performances; and

WHEREAS, the Men's team members competing at the NCAA Indoor Championships included Devin Dixon, Robert Grant, Elijah Morrow, Fred Kerley, Mylik Kerley, Richard Rose, Lindon Victor, Will Williams, and Audie Wyatt; and
