Mr. Mays said the purpose of this special meeting was to consider and take action on the Authorization for the Interim Chancellor to Execute Lease to M.D. Anderson Hospital and Cancer Center. Mr. Delmar Cain, General Counsel, explained that in the background information there is a requirement that approval is needed from the Department of Agriculture before the Chancellor can execute this lease. On motion of Mr. Nye seconded by Dr. Wynn and by a unanimous vote, the following minute order was approved:

The Interim Chancellor of The Texas A&M University System, or his designee, following review by the System Real Estate Office and the Office of General Counsel, is authorized to negotiate and take all steps necessary to enter into all documents to lease space within the Albert B. Alkek Institute of Biosciences and Technology Building to the M.D. Anderson Hospital and Cancer Center. The primary term of this lease will be for a period of three (3) years with the option to renew on a month-to-month basis to accommodate unexpected delays in construction of M.D. Anderson Hospital and Cancer Center's permanent facilities in the Texas Medical Center. The base rental rate for the first year will be \$27.00 per square foot per year, and will be escalated each year thereafter.
