## October 2011 – BPP Enhancements

### MSP Edit on Payroll Add/Correct Source Screens

MSP (Medical Supplemental Payment) is no longer allowed to be entered on the Payroll Add/Correct Source Screens for sources with a pay period end date after 08/31/2010.

#### AD&D Pretax Deduction Amount Added to 126 and 757

The Pretax Waive Flag on Screen 106 determines whether a person will have deductions taken pretax for medical, dental, vision, and/or AD&D. The Pretax fields can be viewed on the Insurance Type Detail Screens (Screen 120 – Medical; 121– Dental, 129 – Vision, and 126 - AD&D) and Benefit History by pressing the PF11 Key on the 757 screen. Previously, the pretax fields for medical, dental, and vision were displayed on their respective screens, but AD&D pretax values were not. Both Screen 126 and 757 were recently enhanced to show the AD&D pretax amount.

#### Master Error List Error 8471 - Active SGIP Elig Code with No Insurance

This error is usually reported when a person has an active SGIP Eligibility Code on the 101 screen but is not enrolled in Insurance. This error will no longer be reported for records that have a locked iBenefits record since it is assumed that iBenefits will either post benefits for this record or update the SGIP Eligibility code to resolve the error.

## **Comment for Dropping Med for Dependents Turning 26**

A new comment will be written to Screen 106 and Benefit History stating "BP8096N – Dependents turning 26 – Med" when medical coverage for dependents turning 26 is turned off on the 115 screen and, if necessary, the number covered and family indicator is adjusted on Screen 106.

## **COBRA Notify Report**

BP7077 is a weekly report that reports employees who potentially need to receive a COBRA Termination letter sent due to termination of employment. Anyone with an employee status code of 'T' and a COBRA Notify flag of 'N' and has not had a COBRA Termination letter record send to HRConnect will be reported. The report previously included records that had a letter record sent to HRConnect, but had not yet been downloaded (which sets the Notify flag to 'Y'). The report title has also been updated to read:

Person's Termed with Insurance Coverage within 60 days Who did not get COBRA Term Letter generated in HRConnect
