The Texas A&M University System (A&M System) is seeking bids for the Electronic Computer Furniture Systems (ECFS) tables specified for FPC Project 05-3300 Prairie View A&M University (PVAMU) Engineering Classroom & Research Building, as well as discount pricing from list for a potential master agreement for Electronic Computer Furniture Systems computer tables.

Group P1: Computer Tables for FPC Project 05-3300 PVAMU:

Bid lines 1, 2 & 3 are for the specified computer tables and dealer services for delivery and installation for FPC Project 05-3300 Prairie View A&M University (PVAMU) Engineering Classroom & Research Building in Prairie View, TX. NOTE: The estimated time frame for delivery and install for the items in Group P1 is June 1 – July 28, 2023. NOTE: The award of Group 1 will be a single award.

Group P2: Master Agreement for Electronic Computer Tables

Bid lines 4 & 5 are for discount structure pricing for an Master Agreement for Electronic Computer Furniture Systems tables for future purchases for any of the A&M System's member locations. The decision of the A&M System shall be final.*
