- Additional Charges: Any additional charges not specified in this invitation for bid shall become the responsibility of the bidder/awarded vendor. No other fees or costs can be added once bid responses are received and bid is closed. Bidder acknowledges that pricing submitted in this bid includes ALL / AN costs for product, delivery, installation, or other fees not specifically requested.

Award Criteria: The A&M System will evaluate and make the award to the bid that is determined to be the best value to the A&M System. Best value criteria may include the following: specifications, pricing, ability

- to meet requested delivery and installation timeframe, insurance requirements, HUB Subcontracting Plan requirements including efforts and ability to provide HUB participation (if applicable), the extent to which the goods or services meet our needs, the vendor's past relationship with the A&M System and other state entities, and any other factor the A&M System deems relevant.
- A HUB Subcontracting Plan (HSP) is required for this bid. Failure to submit an HSP will constitute an irregular response and may result in disqualification. Instructions for completing the HSP are in the attached HSP Form Instructions document.
