# AMENDMENT NO. 1 TO THE SERVICE AGREEMENT BY AND BETWEEN THE TEXAS A&M UNIVERSITY SYSTEM AND ARTHUR J. GALLAGHER RISK MANAGEMENT SERVICES, INC.

This Amendment No. 1 ("Amendment") serves to amend the Service Agreement, effective April 21, 2016, between The Texas A&M University System ("TAMUS") and Arthur J. Gallagher Risk Management Services, Inc. ("PROVIDER"), and is effective April 21, 2021 ("Amendment Effective Date"). System and PROVIDER agree to amend the Agreement as follows:

#### 2. TERM ("Renewal Term")

Delete the first sentence of Section 2 and replace with the following:

"This Agreement shall be extended for five-year period beginning April 21, 2021 and ending on April 20, 2026."

#### 5. PUBLIC INFORMATION

Delete this section in its entirety and replace with the following:

- A. PROVIDER acknowledges that TAMUS is obligated to strictly comply with the Public Information Act, Chapter 552, Texas Government Code, in responding to any request for public information pertaining to this Agreement, as well as any other disclosure of information required by applicable Texas law.
- B. Upon TAMUS's written request, PROVIDER will promptly provide specified contracting information exchanged or created under this Agreement for or on behalf of TAMUS.
- C. PROVIDER acknowledges that TAMUS may be required to post a copy of the fully executed Agreement on its Internet website in compliance with Section 2261.253(a)(1), Texas Government Code.
- D. The requirements of Subchapter J, Chapter 552, Texas Government Code, may apply to this agreement and the PROVIDER agrees that the agreement can be terminated if the PROVIDER knowingly or intentionally fails to comply with a requirement of that subchapter.

#### 6. MISCELLANEOUS

Add the following new provisions after provision "S".

**T.** Conflict of Interest. By executing this Agreement, PROVIDER and each person signing on behalf of PROVIDER certifies, and in the case of a sole proprietorship, partnership or corporation, each party thereto certifies as to its own organization, that to the best of their knowledge and belief, no member of TAMUS or The A&M System

- Board of Regents, nor any employee, or person, whose salary is payable in whole or in part byTAMUS, has direct or indirect financial interest in the award of this Agreement, or in the services to which this Agreement relates, or in any of the profits, real or potential, thereof.
- U. **Prohibition on Contracts with Companies Boycotting Israel.** To the extent that Texas Government Code, Chapter 2271 applies to this Agreement, PROVIDER certifies that (a) it does not currently boycott Israel; and (b) it will not boycott Israel during the term of this Agreement. PROVIDER acknowledges this Agreement may be terminated and payment withheld if this certification is inaccurate.
- V. Certification Regarding Business with Certain Countries and Organizations. Pursuant to Subchapter F, Chapter 2252, Texas Government Code, PROVIDER certifies it is not engaged in business with Iran, Sudan, or a foreign terrorist organization. PROVIDER acknowledges this Purchase Order may be terminated if this certification is or becomes inaccurate.
- W. Prohibition on Contracts Related to Persons Involved in Human Trafficking. Under Section 2155.0061, Government Code, the vendor certifies that the individual or business entity named in this contract is not ineligible to receive the specified contract and acknowledges that this contract may be terminated and payment withheld if this certification is inaccurate.

All other terms and conditions not hereby amended are to remain in full force and effect.
