

FIRST ORDER FORM AMENDMENT TO THE LICENSE AND SERVICES AGREEMENT

This First Order Form Amendment to the License and Services Agreement (hereinafter "Amendment"), is entered into by the parties signing as of the date of the later signature, as provided below ("Effective Date"), by and between <u>Texas A&M University System</u> (hereinafter "Customer"), and Interfolio, Inc., located at 1400 K St NW, Suite 1100, Washington, District of Columbia 20005 (hereinafter "Interfolio").

WHEREAS, Customer and Interfolio are parties to an Order Form to the License and Services Agreement, effective as of 10/23/2020 (hereinafter "Agreement"); and any subsequent Addendums and Amendments, which identify the Service to be performed in the Agreement; and

WHEREAS, Customer and Interfolio now wish to amend and revise the Agreement for purposes of adding the Client Advisory Service to the Agreement (hereinafter "Service").

NOW, THEREFORE, the parties do hereby amend the Agreement in the following respects:

- 1. Customer engages and authorizes Interfolio to provide services, as described below and attached herein.
- 2. Notwithstanding anything contrary contained in the Agreement or subsequent amendments thereto, the initial term of the Service, will end as set forth in the Order Form as attached herein. This Amendment will automatically extend for three (3) additional three-year periods, unless at least 120 days prior to the end of the current term of this Order Form, either party notifies the other party in writing of its desire not to extend the term of this Schedule.

The Term and Fees to the Order Form, as attached herein, shall be added to the Agreement for purposes of renewing the Service and as *Client Advisory Service (formerly known as* Annual Project Management Service). This enhanced service is required for all Faculty Activity Reporting Contracts and highly recommended for all Modules.

The service is based on 5% of the annual subscription rate and includes:

- Ongoing access to Client Success Managers
- 2. Utilization Reports
- 3. Product Release Management
- 4. Advisory Support and Faculty Adoption Consultation
- Integration Consultation
- Ongoing access to training resources.

- 4. The defined term 'Agreement,' of the Agreement's terms and conditions shall be added as a new provision to the Agreement's terms and conditions with the following provision:
 - "Agreement" means this License and Services Agreement, including the fee and license schedules as provided in an Order Form ("Order Form") and/or Statement of Work ("Statement of Work"), any exhibit ("Exhibits"), or purchase order ("Purchase Order") to the Agreement that are attached hereto, as mutually agreed upon in writing and as of the Effective Date (and any subsequent amendments that are mutually agreed to in writing by the parties). In the event of any conflict between the documents as mentioned herein, the order of precedence to resolve such conflict shall be the same as the document order set forth above. The License and Services Agreement shall not accept other terms and conditions unless mutually agreed upon and signed by both parties."
- 5. This Amendment may be executed in counterparts, each of which shall be deemed as an original, but all of which together shall constitute one and the same Amendment. The parties' execution and delivery of this Amendment by facsimile, email, or electronic copies shall have the same force and effect as execution and delivery of an original.
- 6. Except as modified herein, all other provisions of the Agreement, including all other addendums, terms and conditions set forth in the Agreement, shall continue and remain in full force and effect.
