

**AMENDMENT No. 6
TO THE AGREEMENT
BY AND BETWEEN
THE TEXAS A&M UNIVERSITY SYSTEM
AND SKY WONDER PYROTECHNICS, LLC**

This Amendment No. 6 (“Amendment”) serves to amend the Agreement, effective November 23, 2020, between The Texas A&M University System (“System”) and Sky Wonder Pyrotechnics, LLC (“PROVIDER”), and is effective August 15, 2023 (“Amendment Effective Date”). System and PROVIDER agree to amend the agreement as follows:

2. TERM OF THE AGREEMENT (“Renewal Term”)

Section 2 shall be replaced in its entirety with the following:

This agreement shall be extended for the period beginning November 23, 2024 and ending on November 22, 2025. This Agreement can be extended for up to one (1) additional one-year terms upon written agreement of both parties. Any extensions shall be at the same terms and conditions plus any approved changes to be determined by A&M System and negotiated in writing with the PROVIDER.

8. MISCELLANEOUS

- Y. Certification as to Discrimination Against Firearm Entities.** To the extent that Chapter 2274, Texas Government Code, is applicable to this Agreement, PROVIDER verifies that (a) it does not have a practice, policy, guidance, or directive that discriminates against a firearm entity or firearm trade association, and (b) it will not discriminate during the term of this Agreement against a firearm entity or firearm trade association. PROVIDER acknowledges this Agreement may be terminated and payment withheld if this verification is inaccurate.
- Z. Certification as to Boycotting Energy Companies.** To the extent that Chapter 2274, Texas Government Code, is applicable to this Agreement, PROVIDER verifies that (a) it does not boycott energy companies, and (b) it will not boycott energy companies during the term of this Agreement. PROVIDER acknowledges this Agreement may be terminated and payment withheld if this verification is inaccurate.



All other terms and conditions not hereby amended are to remain in full force and effect.


