AMENDMENT No. 1 TO THE AGREEMENT BY AND BETWEEN THE TEXAS A&M UNIVERSITY SYSTEM AND ABSOLUTE TESTING SERVICES, INC.

This Amendment No. 1 ("Amendment") serves to amend the Services Agreement, effective September 1, 2021, between The Texas A&M University System ("System") and Absolute Testing Services, Inc. ("PROVIDER") and is effective September 1, 2024 ("Amendment Effective Date"). System and PROVIDER agree to amend the agreement as follows:

2. TERM OF THE AGREEMENT

This agreement shall be extended for the period beginning September 1, 2024 and ending on August 31, 2025.

- AA. **Energy Company Boycotts.** To the extent applicable, PROVIDER represents and warrants that: (1) it does not, and will not for the duration of the contract, boycott energy companies or (2) the verification required by Section 2274.002 of the Texas Government Code does not apply to the contract. If circumstances relevant to this provision change during the course of the contract, Respondent shall promptly notify Agency.
