SCREEN 407 - TAX TREATY MAINTENANCE

This table defines the treaty code categories for foreign national FIT withholdings.

After receiving the screen **407** there are five options available:

- 1. Return to the B/P/P Table Maintenance Menu
- 2. Inquire about a treaty code
- 3. Add a treaty code
- 4. Modify a treaty code
- 5. Delete a treaty code

These options are described below:

1. RETURN

To Return to the B/P/P Table Maintenance Menu:

• Type an **E** or **400** in the **FUNCTION** field and press the **ENTER** key or use the PF3 function key or the PF4 to return to the B/P/P Main Menu.

2. **INQUIRE**

To inquire about a specific treaty code:

- **FUNCTION** field should be blank.
- **TAB** to the **TREATY** field and enter a valid numeric treaty code.
- After desired data is entered, the user should press the **ENTER** key. All information for that specific treaty code will be displayed.
- If the system detects a problem with the treaty code entered, one of the following messages will be displayed: INVALID TREATY CODE, TREATY NOT ON DATABASE or NO COUNTRIES FOR THIS TREATY ON DATABASE.

3. **ADD**

Before a new treaty is added to the database, the user should inquire on it first, as described above, to make sure it does not already exists.

To **ADD** a new treaty to the database:

- **FUNCTION** field should be **A**
- The TREATY field will still be displayed from the previous Inquiry. Enter a valid income code in the INCOME CODE field, enter a valid numeric year in the MAXIMUM YEARS OF PRESENCE field, enter a valid number in the ANNUAL MAXIMUM

EARNINGS field, enter a valid number in the **MAXIMUM EARNINGS** field, and enter the appropriate number of valid country codes in the **COUNTRIES** fields.

- Once all of the desired information has been entered, the user should press the ENTER
 key. The data will be edited, and if no errors are encountered by the system, the database
 will be updated and the following message will be displayed: TREATY ADDED TO
 DATABASE.
- In the event the systems detects an error, the problem field(s) will be highlighted and the appropriate error message will be displayed:

INVALID TREATY CODE
INVALID INCOME CODE
INVALID MAXIMUM YEAR
INVALID MAXIMUM EARNINGS
ONLY ONE MAXIMUM EARNINGS AMOUNT IS ALLOWED
COUNTRY CODE NOT FOUND ON DATABASE
DUPLICATE TREATY EXISTS ON DATABASE

4. MODIFY

Before an existing treaty's information is changed, the user should inquire on it first, as described above.

To **MODIFY** an existing treaty:

- **FUNCTION** field should be **M**
- **TAB** to the fields that require change, and make the necessary updates.
- Once all of the desired changes have been entered, the user should press the ENTER key.
 The data will be edited, and if no errors are encountered by the system, the database will
 be updated and the following message will be displayed: TREATY CHANGED ON TO
 DATABASE.
- In the event the systems detects an error, the problem field(s) will be highlighted and the appropriate error message will be displayed:

INVALID TREATY CODE
INVALID INCOME CODE
INVALID MAXIMUM YEAR
INVALID MAXIMUM EARNINGS
ONLY ONE MAXIMUM EARNINGS AMOUNT IS ALLOWED
COUNTRY CODE NOT FOUND ON DATABASE
TREATY NOT ON DATABASE

5. **DELETE**

Before deleting an existing treaty, the user should inquire on it first, as described above.

To **DELETE** an existing treaty:

- **FUNCTION** field should be **D**
- TAB to the TREATY field, type in the treaty to delete, and press the ENTER key. If no errors are encountered by the system, the database will be updated and the following message will be displayed: TREATY DELETED FROM DATABASE.
- In the event the system detects an error, the problem field(s) will be highlighted and the appropriate error message will be displayed: **INVALID TREATY CODE** or **TREATY NOT ON DATABASE**.
