Is deleted and is replaced with "The term of this Agreement shall be renewed for three years effective April 1, 2020."

Nothing contained herein shall be held to alter or affect any of the terms and conditions of said Agreement other than as herein stated. All other terms of the original Agreement, as amended, shall remain in force and effect.

IN WITNESS THEREOF, intending to be bound, the parties have entered into this Amendment No. 1 of the Agreement effective as of April 1, 2020.




