## Inactivation of HCPro HIPAA courses

Hope you are finally enjoying some fall weather. I am writing to let you know that the 12 HIPAA-related courses below are no longer active in TrainTraq as of today. These courses—which were part of a set of 14 HIPAA-related courses developed by a company named HCPro—had very low usage. As a result, the System Office of Risk Management has not renewed the license for the 12.

  employees who handle employee benefits-related information and other users with
  administrative access to Workday.
