Dear A&M System Training Coordinators:

Two new courses, 2112755: Comp Time Issues for Employees and 2112756: Comp Time Issues for Supervisors will be made available in TrainTraQ on July 1. The courses cover the differences between the Fair Labor Standards Act (FLSA) compensatory time, state compensatory time, and holiday compensatory time. The content was provided by the Division of Human Resources & Organizational Effectiveness of Texas A&M University.

In addition, courses 8002: Time Off Issues for Employees and 2001: Time Off Issues for Supervisors, which both previously included a section about compensatory time, will no longer include this content. The Time Off courses will solely address the different types of paid and unpaid leave.
